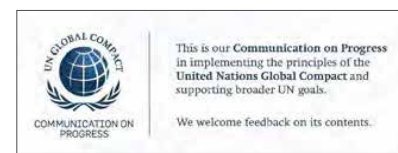


## Participation in Major Associations and Organizations
